# 2.2.4. The Impact from the Nature of Parents' Occupation

#### 3. Conclusion

The indirect impact is that high economic conditions social class can not only bring children a broad perspective and in-depth understanding of the world but also support children to try new things and cultivate diverse hobbies, such as spending money on

traveling or participating in public welfare, which provides them a more prosperous life experience.

The nature and type of parents' occupations affect children's education in two ways. First, children can contact their parents' occupations closely, learning from their parents' knowledge and experience in these occupations and clarifying whether they are interested in them, which lays the foundation for their future career choices. Second, parents educate their children based on the professional experience and abilities they have acquired in their career and the values accumulated from it, leading to different educational expectations, priorities, and educational results for their children.

The literature analysis in this research ignores the children's talents, personal interests, and the parents' country, region, ethnicity, language circle, religious beliefs, and other variables, making the conclusions have certain limitations. However, for today's society and future research directions, the results still have essential meanings.
