President Wilson showed his superb strategies during the turbulent period. At the beginning, the United States was neutralized because President Wilson claimed that the isolated policy was optimal for the United States. With the development of the War, since the situation was changing, President Wilson sent the U.S. troops to the Europe, and assisted allies won the war. The remarkable contribution in President Wilson's foreign affair career was the Fourteen Points. This theory is a milestone of IR theory because the new branch of IR theory, namely Liberalism, has been introduced along with the development of the Fourteen Point. [6]

Given that President Wilson's superb academia achievements, he was able to handle with complicated international affairs at that tremendous period. His theory namely Fourteen Points, has farreaching influences on the international affairs. Because of his contributions, the United States avoided to enter the war in the early time, and benefited from this decision.

# 2.2. Henry Kissinger

Another remarkable politician/scholar is Henry Kissinger. His outstanding contribution to deal with the Sino-U.S. relationship has deeply influence on the international affairs.

Henry Kissinger is a Chinese affair expert, he plays an important role in the normalization of the Sino-U.S. relationship. In his early life, he enrolled at Harvard University and received Ph.D. degree. After that, during the Nixon administration, he was appointed as National Security Advisor.

Prior to the early 1970s, China was isolated from the West World, the communications between China and the United States were rare. Because of the Cold War, the tensions between the U.S. and the Soviet Union increased during this time. Henry Kissinger, as the National Security Advisor, had to rethink about the Sino-U.S. relations. In 1971, Henry Kissinger made his secret visit to China, this was marked as the watershed of the Sino-U.S. relationship. [7]

Henry Kissinger, as a senior diplomat, is influential in the international affairs. His dedication of normalizing the relationship between China and the U.S., is not only beneficial to China and the United States, but also the whole world. Back to the Cold War era, when the relations between the Soviet Union and the U.S. were at risks, his decision of secretly visited to China shocked the global community. This is largely due to his educational career at Harvard University, where he read multiple books, finished his dissertation, and then got Ph.D. degree. Later, he put theories into the practice.

# 2.3. Yuanpei Cai

Yuanpei Cai, a notable Chinese educator, has remarkable contribution to Chinese educational system. Cai Yuanpei, lived in a revolutionary period, has a legendary life. In his early life, by his effort, he received degree from the Qing dynasty, and was appointed as an officer. This was an optimal job for Chinese at that time. Nevertheless, Cai Yuanpei was deeply influenced by the Western thoughts, and later he went to Germany and received degree.

Later, he returned to China and was appointed as the President of Peking University. During the time he was at Peking University, he reformed the traditional educational system, renewed and introduced various courses, and invited different professors, scholars, experts and so forth to Peking University. The most significant contribution to the Chinese education was that he set a principle to be an excellent student. This principle includes various dimensions which are related to virtue, beauty and health. Moreover, he encouraged new thoughts at Peking University, it facilitated the New Cultural Movement, and fundamentally influenced politics at that time. [8]

Cai Yuanpei's educational theory has far-reaching influences on the Chinese educational system until now. Currently, the educational reform in China stresses we should let every student not only study well, but also know what is beauty, and how to become beauty. It is clearly that the reform is largely influenced by Cai Yuanpei. It should be noted that due to Cai Yuanpei's efforts, Peking University became a center for new thoughts, new values and new culture at that time, it significantly impacted on politics.

# 2.4. Angela Merkel

The former German Chancellor Angela Merkel demonstrates the strong relationship between education and politics. Prior to her political career, she held doctorate degree, meanwhile, she was a notable scientist in the chemistry field. [9] When she became the Chancellor, she was able to deal with the international affairs in a rational way and was considered as a successful leader in German history. Europe encountered great crisis when she was the Chancellor of Germany, many serious problems, for instance, refugees, financial crisis and the relationships with Russia and China, should be solved immediately. More importantly, these issues were complicated, it was impossible to solve the problems without a qualified leader. Seriously, if problems could not be solved properly, they would be even worse than before.

Angela Merkel was elected as the German Chancellor at the moment when both Europe and Germany were in momentous period. Facing the crisis, she exerted outstanding political methods to dealt with every single problem. The most valuable legacy is that her rationalities in solving international affairs. Let put it concrete, she united all kinds of political entities together, and negotiated with them by using moderate terms. By doing so, she earned reputations from other political leaders. As a result, problems were solved in a comfortable climate. # 4. Conclusion
