Tweets and Reactions: Revealing the Possible Misuse and Astray Development of Online Feminism Movements

Abstract: How do tweets shows online feminism campaigns can be misguided and lead to irrational comments about specific affairs and individuals? This article analyzes the public's reactions towards the case of Johnny Depp and Amber Heard on Twitter using topic modeling. Also, the report introduces some comparative perspectives on hashtag feminism and provides a link between those theories and actual reactions so that both of them can be better explained. The outcome states that there was an obvious shift in topics between the period of Amber Heard expanding the influence of her accusation towards Johnny Depp using #Metoo and the period of Johnny Depp proving himself innocent through a lawful trial. That is to say, the previous criticism of Johnny Depp and support for Amber Heard lack the judgment to a certain extent. More specifically, these relatively non-objective reactions were due to some of the characteristics of hashtag feminism. And in turn, this study points out that preventing further misuse of online feminism movements will require more studies to have a more detailed understanding of how should online feminism movements operate to help those genuinely in need.

Keywords: feminism, Twitter, Metoo movement, hashtag feminism

1. Introduction

The feminist movement running online is a nonnegligible part of the development of the modern feminist movement [1]. Clark also pointed out some of the advancements and defects of hashtag feminism [1]. However, the studies that emphasize its possible astray or even extreme development are deficient, especially the one with dependable quantitative data analysis to support it. Our research is valuable by filling this gap to a certain extent. In addition, our research is necessary for both practical and academic reasons as follows:

Even if the trial was eventually won, Johnny Depp suffered a considerable loss in time, money, reputation, and his interpretative career. Many Twitter users also experienced great humiliation after the trial due to their non-carefully considered behaviors online. Besides all these, the case of Johnny Depp and Amber Heard lasted for over five years. It took up tremendous public attention and resources, which could have been used on more valuable affairs and made a difference. Our study

provides objective and credible warnings for users involved in similar online disputes in the future, providing a degree of protection for the public resources, the user's own words and actions, and individuals who may be wronged.

Internet feminism on the hashtag is a reliable tool for developing feminist movements [2]. However, this misuse can seriously damage the reputation of the online feminist movement, seriously undermine the enthusiasm and support for similar activities, and thus obstruct the better development of the feminist movement. So, it is necessary to expose the potential misuse of the online feminist movement.

For the first time, we combine and argue the results obtained by applying Topic modeling (using MDCOR(Machine Driven Classification of Open-ended Responses) with a theoretical view (in the field of social media). This provides a more reliable data source (or arguments) for almost all existing ideas, theories, or perspectives in the relevant field.

Aiming to make some contributions to the circumstances above, our research tends to combine data gathered from Twitter with some views related to online feminism and emphasize the possible misuse and astray development of online feminism movements.

To achieve this goal, we will introduce our Literature, Theoretical Guidance, Materials and Methods, Results, Discussion, and Conclusion sections.

2. Literature Review

2.1. #Metoo Campaign- Female Victims' Exposure Events

#MeToo campaign originated in 2006 as an effort by Tarana Burke to support victims of sexual harassment and end sexual violence [3]. Burke focused on black girls and women and their struggles, particularly around issues of racial and gender equity. In 2017, celebrity public figures disclosed their incidents of violence and sexual assault on the topic of #Me too. After 24 hours, 12 million people cited this to share their painful experiences under that topic. Since then, it has triggered an upsurge in online feminism.

In the early stage of the dispute, Amber Heard took advantage of the public and female groups' enthusiasm for feminism discussion and the influence of the "MeToo" movement on American social platforms to emphasize her experience of domestic violence and link it with the women's anti-violence movement. Many of the comments in this period have used hashtags such as "MeToo" and "istandwithamber" to support the woman who is fighting back against domestic violence and feminism.

2.2. Johnny Depp and Amber Heard

Johnny Depp and Amber Heard are two actors and actresses in America. In 2013, Johnny Depp and Amber Heard opened their relationship to the public. Over two years later, on February 4th, 2015, they married. On May 27, 2016, Amber Heard filed for divorce and accused Johnny Depp of domestic abuse, while Johnny Depp said he was the victim. On August 16, 2016, the two issued a joint statement and reached a divorce settlement in which Amber Heard dropped her domestic abuse charges against Johnny Depp; then, he paid \$7 million to the woman. After that, when the time came to November 25, 2016, on the European Union's International Day for the Elimination of Violence against Women, Amber Heard spoke out in a touching video about her experience with domestic violence. The couple officially divorced on January 4, 2017. In December 2017, J.K. Rowling met with a wave of boycotts and abuse for supporting Johnny Depp's role as Grindelwald. In April 2018, the British tabloid *The Sun* reported on Amber Heard's allegations against Johnny Depp and even used the word "wife-beater" when commenting on Johnny Depp. After that, In August 2018, Johnny Depp prosecuted *The Sun* for defamation.

December 18, 2018, Amber Heard hinted at domestic abuse and put out a separate op-ed for her in a Washington Post article titled "I'm Against Sexual Violence" about the domestic violence she became a victim of in 2016. This is when Amber Heard attracted more attention than ever and became a powerful representative of the #MeToo campaign by using hashtags to post online.

Earlier in 2019, the Daily Mail released an audio recording confirming that Amber Heard committed domestic violence against Johnny Depp. She said that I was hitting you, not punching you. Then, On March 1st, 2019, Johnny Depp sued Amber Heard for \$50 million for that article—the time frame shifted to the court case against *The Sun*. During the trial, Johnny Depp revealed the big shock news that Amber Heard cheated on the Tesla president, Elon Musk. On July 28, 2020, the problem of Johnny Depp's defamation suit against *The Sun* newspaper ended. In the same year, a London court ruled in the first instance that Johnny Depp had lost his lawsuit against *The Sun* for defamation and that Johnny Depp had the option to continue his appeal on November 2. Finally, two years later, on the 11th of the month, Johnny Depp sued his ex-wife for defamation. To redeem his reputation, Johnny Depp immediately launched a defamation lawsuit for \$50 million, and Amber Heard also found \$100 million in court directly. The defamation case was finally decided in favor of Johnny Depp, and this farce was also over on June 1, 2022.

Amber Heard pushed Johnny Depp into the guidance of public opinion, Johnny Depp resulting in a compensation of 7 million US dollars for Amber Heard to cancel the charge of domestic violence against him; his acting career was severely damaged because of that situation. He was kicked out of the film series *Pirates of the Caribbean*; The film director J.K. Rowling who was chosen to play the role was also blamed and abused for his incident with Amber Heard. Amber Heard used extreme feminist reports and public opinion to accuse his ex-husband of dishonesty and destroying his acting career by selling poorly for most of his life.

3. Theoretical Guidance Basis

3.1. Hashtag Feminism and Related Theories

Hashtag feminism contains specific characteristics as follows:

- (1) As a form of online movement, hashtag feminism contains inevitable characteristics of the internet: anonymity, low-standard regulations, and supervision that lacks deterrence [4].
 - (2) Rumors and online violence are possible phenomena of Hashtag feminism [1].
- (3) As an extensive discussion process, the group polarization phenomenon is likely to happen in the circumstance of hashtag feminism [5].
- (4) Hashtag feminism can be considered a kind of Slacktivism, which only uses a certain tag on social media platforms to support a certain incident or individual but does not take any action [6].

Our research will take these perspectives of Hashtag feminism as necessary consultations to help us analyze the reactions users have on Twitter and how these reactions reflect the possible misuse and astray development of online feminism movements

Hence, we raise the following questions:

How does Twitter react to the fact that hashtag feminism may be misused and lead to the consequence of lack of judgment?

To achieve this goal, we will first address:

What are the topics in the two periods? How do these two groups of topics represent the attitude shift of the masses?

4. Materials and Methods

4.1. Data Collection

We used R language to perform data collection of crowd reactions on Twitter. First, we manually bookmarked all tweets related to Amber Heard and Johnny Depp from 18/12/2018 to 18/3/2019, which became our first period. We selected hashtags such as "#ImWithAmber", "#ImWithJohnny", "#wearewithyouamberheard" or "#JohnnyDepplsAWifebeater" and other keywords. This period is exactly when Amber Heard implied she was being domestically abused in the Washington Post article and used the ferment of the Metoo movement to greatly expand her public influence; not only that, but it was also the period when Johnny Depp was most heavily criticized by the public.

Second, we set 11/4/2022 to 11/7/2022 as the second period and collected tweets related to Amber Heard and Johnny Depp. Among them, we collected tweets based on hashtags such as "#IstandWithVictims", "#TruthWin", "#JohnnyDeppIsInnocent", "#GiveAmberHerVoiceBack" and "#AmberHeardlsAnAbuser" to retrieve tweets. And the period when Johnny Depp sued Amber Heard successfully, the crowd found the truth in shock and transformed to support Johnny Depp.

4.2. Ethical Attention

As a public social platform, Twitter is known users when they log in that their messages will appear on the public forum. Therefore, there is no ethical issue with our selection of public data. Nonetheless, in the interest of higher ethical standards and complete protection of the privacy of the Twitter community, we process data with the names, genders, and identities of our users hidden, particularly geographic location and other more sensitive personal information.

4.3. Data Analysis

We use a quantitative research approach to conduct analysis. The topic modeling method was used by applying the Machine-Driven Classification of Open-ended Responses software, also known as MDCOR [7].

4.4. Topic Modeling Process (Using MDCOR)

- a) We first select the csv. file which is extracted online using R and upload it as a database.
- b) Select two columns (author ID and context) and click "execute text mining", allowing the software to identify and list out only the wanted two columns in the software's form.




Figure 1: Metrics output.

- c) Select execute metrics to gain metrics output. The results will appear as a linear graph that contains four changing lines (Figure 1 Shown as below).

d) Choose the topic number (optimal number of codes) based on the metrics plot.

The top two lines are closer to 0, which means they are independent and not co-related, while the bottom two lines are closer to 1, which means they are similar and related.

Comprehensively referring to those four lines. Take period two as an example; we chose six topics.

- e) Set the optimal number to the selected six topics and run the MDCOR. The final results will contain the following:
 - 1) Visualization charts with six different topics and their top 30 salient terms (see Appendix 1)
 - 2)Top 20 representative tweets for each topic (see Appendix 2)
 - f) Artificially label the topic with matching categories and names.

5. Results

Due to the data of period one (from 18/12/2018 to 18/3/2019) still going through the collecting process, we carefully simulated the collecting process manually. We read over 5000 tweets with related hashtags from this time quantum. Five of our researchers read all of them individually and wrote down their decided topic classifications. After that, we compared these classifications and came up with different categories, all of which stand for firm support for Amber Heard and sharp criticism for Johnny Depp.

Through topic modeling using MDCOR, the issue of period two are:

Topic one(V1): Stressing that men can also be victims of domestic violence

Topic two(V2): Promoting and requesting the public to sign the petition that favors Johnny Depp and other similar cases.

Topic three(V3): Quoting previous hashtags that favored Amber Heard to condemn her behaviors.

Topic four(V4): Counting Amber Heard's various behaviors and blaming her for them.

Topic five(V5): Reviewing the hardships of the case with hashtags and celebrating Johnny Depp's victory.

Topic six(V6): Quoting 'Captain Jack' (A character that Johnny Depp played) to celebrate Johnny Depp's victory

By comparing the two groups of topics, the shifts in the public's options are definite. It is evident that the people, especially the feminists and #MeToo movement participants, were supporting Amber Heard with great enthusiasm and belief while judging Johnny Depp for crimes that have proven to be fabricated. They made assumptions and conclusions based on only their trust in Amber Heard and

her words. This indicates feminist movement online has the possibility to be misguided, even gone extreme.

6. Discussion

The application of Tweets data gathered by R and processed through MDCOR as a source to analyze public opinion and demonstrate ideas in the field of social media is considered a highlight of our research. Unlike most research methods, topic modeling using MDCOR is a quantitative approach. It leaves out the problems like prejudice options, lack of desire or ability to express for the interviewee or offset answers caused by leading questions. Compared with most qualitative methods commonly used in this area, topic modeling is a new path that can be easily used.

Also, this specific software breaks some of the limitations of quantitative research itself, by tagging text into categories or codes, we can gain many distinguished benefits:

- a) a thorough understanding of the process and causes of research and making clear comparisons.
- b) MDCOR has leading efficiency and reliability, significantly reducing the consequences of subjectivity and human error in classification. Not only that, but this will also avoid the time and human error consumed by traditional manual type. This approach will enhance the contribution of the answers to enhance our understanding.
- c) MDCOR, because it runs locally, can analyze protected or restricted data and obtain information efficiently and rigorously.

Another critical point of our study is revealing the possible extreme development of feminism operating through the internet due to some of the defects of hashtag feminism. With the proliferation of social media, the feminist movement is adapting to and exploiting these hashtags. Represented by the use of hashtags to publish comments related to feminism on Twitter is not only a kind of feminist activism but also an important branch of contemporary online feminism.

The intrusion of the Internet into our lives has caused most of our "demonstrations" to move to the Internet. As a variant of social movement occurring at the media level, Hashtag feminism has specific advancement. For example, public discussions on female-related issues with the help of hashtags often reveal some defects in the legal, governmental, and cultural aspects. The outcry has forced the authorities to pay attention to such problems, thus promoting social change and progress. But its limitations have come to the fore in Johnny Depp and Amber Heard's dispute.

Regarding the conflict between Johnny Depp and Amber Heard, the comments of Twitter users are characterized by radicalism and blind obedience, which is related to hashtag feminism. It is precise because Hashtag feminism relies on the media of the Internet, and its inherent nature with the Internet makes it easier to radicalize the discourse on issues related to feminism with the help of hashtags. First, the network anonymity and tolerance of the network management regulations lead to it for individuals involved in cost-lower social movements, such as the risk of suffering detention penalty because of improper comments is significantly reduced, which makes the network speech can be more brazen, compared to traditional forms of the feminist movement, Abusive words, the spread of rumors and Internet violence is the more distinctive characteristics of Hashtag feminism. Secondly, another inducement of radicalization is group polarization in the transmission process. Feminist-related issues in the discussion on the network on a large scale is a kind of collective discussion; according to James Stoner, who discovered in 1961 the group discussions are prone to the "group polarization" phenomenon, this extensive group discussion to produces "The extreme majority", their opinions and expression tend to extreme and radical. In addition, group polarization also leads to group-wide mental decline. It's easy to understand why, in the early days of Johnny Depp's dispute, Twitter users decided that Amber Heard was the victim of the violence based on a few docile photos and used offensive language against Johnny Depp.

Hashtag Feminism uses the power of text expression and groups on the Internet to make it a more moderate social movement and even revolution. However, the understanding of the "moderation" of Hashtag feminism is complex and multi-faceted. Some scholars still believe that Hashtag feminism is a kind of Slacktivism that only uses a certain tag on social media to support a certain event and a certain person but does not take any action. However, the fundamental or more noteworthy limitation of this so-called mild social movement is not its limited promotion of social reform but its full expression of radical expression and the manifestation of mass intellectual degradation. This undoubtedly casts a shadow on the enormous feminist system behind Hashtag feminism. It is also more detrimental to discussing relevant events and the final presentation of the truth.

7. Conclusion

This article used a quantitative approach to reveal the possible misuse and astray development of online feminism movements. Our research points out that some of the characteristics of hashtag feminism sometimes lead to extreme comments online. These characteristics may include slacktivism, group polarization, and an online environment that is anonymous, low-standard, regulated supervised. That is to say; this study highlights the commonly overlooked potential for feminism to be misused or to extremes when operating online.

Given the increasingly influential development of the feminist movement, especially the online feminist movement, we believe that early identification of its disadvantages and possible adverse effects is necessary. Only with an in-depth understanding of the characteristics of the online feminist movement and an argument combining these characteristics with real-life phenomena can we indeed use the Internet as a unique tool for developing feminist movement excellence. From this perspective, we call for more public research in related fields.
